- Drivers under the age of 20 are now eligible with one incident (violation or at fault accident)
- Required underlying limits for drivers under the age of 22 have been reduced to 250/500/50 or 300/300/50 or 300CSL
- Limits up to \$5M are now available to applicants previously limited to \$1M based on number of autos and/or properties.
